The data subject of data processing is the minor who submits an application through the parent (legal statutory representative) and the parent (legal statutory representative) participating in the application.

Duration of data processing

The Data Controller will retain the personal data until the end of the course.

Rights of the data subject in relation to data processing

Right to request information

Through the contact details provided, you may request information in writing from the data controller, you may request the correction or deletion of your personal data, and the restriction of data processing, except where this is impossible due to a legal obligation.

Upon request, the Data Controller shall provide information on the data processed by the Data Controller, the purpose, legal basis, duration of data processing, the name, address (registered office) of the Data Controller, the name, address (registered office) of the Data Controller, the name, address (registered office) of the Data Controller, and its activities related to data processing, the contact details of the Data Protection Officer, as well as who receives or has received your personal data and for what purpose, as well as your rights related to data processing, as well as the measures taken by the Data Controller. The Data Controller shall provide the information in writing, in an easily understandable form within the shortest possible time from the submission of the request, but not later than within 1 month. If necessary, taking into account the complexity of the application and the number of applications, this deadline may be extended by a further two months. If the request for information is unfounded or excessive, especially due to its repetitive nature, the Data Controller may determine the reimbursement of costs or refuse to take action on the basis of the request.

Right of access

You have the right to receive feedback on whether your personal data is being processed. Based on the right of access, you have the right to access the personal data related to the ongoing processing and the following information:

- Purpose and legal basis of data processing
- the categories of personal data concerned;

- the duration of the data processing,
- who receives or has received your personal data and for what purpose,
- your rights in relation to data processing,
- the right to lodge a complaint with a supervisory authority.

At your request, the Data Controller will provide you with a copy of the personal data that are the subject of data processing, provided that it does not adversely affect the rights and freedoms of others. The Data Controller may determine a cost reimbursement for the additional copies requested by you.

Delete your data

You may request the deletion of your personal data in writing via the contact details provided, if the purpose of data processing has ceased to exist, if the processing of such data is unlawful, if the specified period for storing the data has expired, and if it has been ordered by a court or authority. The Data Controller will notify you of the deletion and all those to whom the data was previously forwarded for the purpose of data processing. You will omit the notification if it does not violate your legitimate interest with regard to the purpose of the data processing. The Data Controller shall not delete personal data if they are necessary for the fulfilment of a legal obligation and for the submission, enforcement or defence of legal claims.

Restriction of processing

You may request in writing that the processing of your personal data is restricted by the Data Controller through the contact details provided, if:

- contests the accuracy of the personal data (in this case, the restriction applies to the period during which the Data Controller verifies the correctness of the data);
- the processing is unlawful, but you oppose the erasure of the data and request the restriction of its use;
- the purpose of data processing has ceased to exist, but you need them for the establishment, enforcement and defence of legal claims,
- and if you request it.

The restriction of processing will last as long as the reason you have indicated is necessary. In this case, the personal data, with the exception of storage, will only be processed with your consent; or to establish, exercise or defend legal claims; or to protect the rights of any other natural or legal person; or it is handled in the public interest. The Data Controller will inform you in advance about the lifting of the restriction at your request. *The Data Controller does not restrict the processing of personal data if they are necessary for the fulfilment of a legal obligation and for the submission, enforcement or defence of legal claims.*

Right to object

You may object in writing to the processing of your personal data (including profiling) through the contact details provided, in which case the Data Controller will no longer process your data and will delete them.

In case of any problems or comments, please contact us at the contact details above. It is also possible to go to court: in data protection cases, claims are decided by the competent court. In addition, it is possible to visit the supervisory authority².
